Inspector Note: Stairs to front entry and porch area show signs of cracking and lifting away from house foundation. Area shows substantial movement which may indicate larger foundation issues.  Replace deck in following location: (INSPECTOR DETAIL). Unless otherwise noted materials are to be replaced in-kind. Price to include cost of plan development, review, and approval. If alterations to layout or design are required plans are to be reviewed and approved by client prior to submittal.  1. Demo and dispose of existing deck.  2. Rebuild deck to existing dimensions. Ledger, railing, handrails, stairs, connectors, piers, landings posts, and post bases to be to code. Replace with like materials and PTDF where required/recommended.  3. Apply transparent stain or paint where needed depending on homeowner preference.

Pour new pathway to match existing layout. Driveway to be rebar reinforced and with gravel base layer to industry standards.
